Requirements for Marriage Registration Under Indian Christian Marriage Act 1872

1. At least one of the parties to marriage should be Christian and Domiciled of Maharashtra.
2. Age of Bride (Girl) should be 18 years & above and Bridegroom (Boy) should be 21 years & above
3. One of the parties to Marriage should give notice in prescribed form with relevant Documents at least 3 weeks before date of Registration. The notice will be valid for 60 days.
4. While submitting notice, following copies of documents of both the parties required to be attached to Form of Notice. And bring all original documents for verification.
 - 1) Baptism Certificate 2) Ration card 3) Aadhaar(UID) (must if available)
 - 4) Passport (must if available) 5) PAN Card or Driving License (must if available)
 - 6) Voter Photo Id 7) Photograph of both parties pasted on Notice form.
5. One of the parties who is Christian and Domiciled of Maharashtra can give notice. Notice form should be filled legibly in CAPITAL LETTERS. Notice form is to be signed before Marriage Registrar.
6. After acceptance of notice, Marriage Registrar will give the date for registration.
7. On the date of Registration, the parties to Marriage along with two witnesses will have to present in the Office of Marriage Registrar on the above address.
8. While coming for Registration parties to marriage and **witnesses should bring one of the following photo identities for entry in Mantralaya.**
 - 1) Voter Photo Id 2) Passport 3) Driving License / PAN Card
 - 4) Photo identity letter issued by S.E.O.or Gazetted officer, 5) Aadhar Card.
9. **Xerox Copy of I D proof (Showing name, address, Photo & signature) of witnesses is also required on the date of Registration. And bring all original documents for verification.**
